AND/OR INCENTIVES AND/OR EXPATRIATE POSTS FOR SELECTED
SERVICES SUB-SECTORS**

1. Companies undertaking selected services/activities in the Appendix A may apply for status and/or incentives and/or expatriate posts.
2. Applications should be made using the relevant forms as follows:-
