NOTIFICATION FOR LOGISTICS COMPANIES TO OPERATE DURING MOVEMENT CONTROL ORDER (MCO) FROM 13 JANUARY 2020

This statement refers to the Special Address by Yang Amat Berhormat Prime Minister of Malaysia on 11 January 2021 on the Implementation of the Movement Control Order (MCO) in Johor, Melaka, Kuala Lumpur, Putrajaya, Labuan, Selangor, Penang, and Sabah from 13 to 26 January 2021.

In this matter, MOT acknowledges the issues and challenges faced by the public in ensuring that trade and logistics activities continue to operate smoothly and safely. Therefore, to ensure unhindered movement, owners of commercial vehicles are not required to request endorsement letter from MOT.

Please be informed that restrictions will not be placed on commercial vehicles operating during the MCO. Owners of commercial vehicles need to produce the verification letter from their employers when requested by enforcement personnel, special lanes will be designated at all roadblocks for commercial vehicles.

For other logistics companies such as freight forwarders and warehouse operators that are registered with an association, an endorsement from MOT can be obtained from their respective associations. This letter must be shown together with proof of membership in the association when requested by enforcement personnel at roadblocks.

For companies that are not registered under any association or non-governmental organisation, an endorsement letter can be applied at <https://application.mot.gov.my/>.

The Ministry wished to remind the public to comply with the SOPs established by the Government at all time. Public transport users are advised to comply with the related SOPs and guidelines as announced by the National Security Council (NSC), practice physical distancing, and maintain good hygiene as preventive measures to ward against COVID-19 transmission.
