## **MEDIA STATEMENT**

### **TRAVEL APPROVAL LETTER TO OPERATE FOR LOGISTICS AND TRANSPORTATION SECTOR THROUGH SMILE SYSTEM AND ACTIVITIES PERMITTED DURING NRP AND EMCO PERIOD**

Following the announcement of the National Rehabilitation Plan (NRP) and the implementation of the Enhanced Movement Control Order (EMCO) in several townships in Selangor and several localities in the Federal Territory of Kuala Lumpur from 3 July 2021 to 16 July 2021, the Ministry of Transport Malaysia (MOT) would like to inform that companies in the logistics and transportation sector are allowed to continue using travel approval letters issued under the SMILE System dated from 1 June 2021 for inspections at roadblocks (SJR).

Meanwhile, the latest letter which takes into account the transition from the MCO Phase to the NRP is available for download from 5th July 2021 from the SMILE system via the website <https://application.mot.gov.my>. Eligible companies are encouraged to download this letter.

For loading/unloading of non-essential items, it is only allowed outside EMCO areas nationwide based on existing SOP. Whereas for areas within EMCO, it is limited to warehousing companies which are part of the supply chain servicing ports and airports as stipulated in the SOP for Selangor and KL EMCO. For sectors other than warehousing, loading/unloading activities are limited to companies listed in the EMCO essential list only.

The warehousing sector is not limited to sectors involving only essential goods as it provides storage and unloading services of all finished goods to the ports and airports. The activities of the warehousing sector also do not directly involve any manufacturing activities. Accordingly, the warehousing sector is allowed to continue to operate to handle both essential and non-essential goods.

## KENYATAAN MEDIA

### SURAT KEBENARAN BEROPERASI BAGI SEKTOR LOGISTIK DAN PENGANGKUTAN MELALUI SISTEM SMILE DAN AKTIVITI YANG DIBENARKAN SEMASA TEMPOH PPN DAN PKPD

Susulan pengumuman Pelan Pemulihan Negara (PPN) dan pelaksanaan Perintah Kawalan Pergerakan Diperketat (PKPD) di beberapa mukim di negeri Selangor dan beberapa lokaliti di Wilayah Persekutuan Kuala Lumpur bermula dari 3 Julai 2021 sehingga 16 Julai 2021, Kementerian Pengangkutan Malaysia (MOT) ingin memaklumkan bahawa pemain industri sektor logistik dan pengangkutan **boleh terus menggunakan surat kebenaran beroperasi (Sistem SMILE) bertarikh dari 1 Jun 2021 dan ke atas bagi pemeriksaan di Sekatan Jalan raya (SJR).**

Walaupun bagaimanapun, surat terbaharu dengan pindaan mengambilkira peralihan dari Fasa PKP ke Pelan Pemulihan Negara (PPN) sedia dimuat turun pada hari ini, 5hb Julai 2021 dari sistem SMILE melalui laman sesawang <https://application.mot.gov.my>. Pemain industri digalakkan untuk memuat turun surat ini.

Bagi aktiviti *loading/unloading* barangan *non-essential*, ianya hanya dibenarkan di kawasan luar PKPD sahaja (di seluruh negara) berdasarkan kepada SOP sedia ada. Manakala bagi kawasan dalam PKPD, ianya hanya terhad kepada syarikat pergudangan sahaja kerana syarikat ini merupakan perkhidmatan rantaian kepada pelabuhan

dan lapangan terbang (*services to ports and airports*) yang mana perkara ini jelas dibenarkan dalam SOP PKPD Selangor. Bagi sektor selain pergudangan, aktiviti *loading/unloading* hanya terhad kepada syarikat yang tersenarai dalam senarai *essential* PKPD sahaja.

Sektor pergudangan tidak tertakluk kepada had operasi barangan *essential* sahaja kerana ianya menyediakan perkhidmatan penyimpanan dan pemunggahan barangan siap kepada pelabuhan. Aktiviti sektor pergudangan ini tidak melibatkan sebarang aktiviti pembuatan. Sehubungan itu, sektor pergudangan boleh terus beroperasi tanpa kekangan kepada jenis barangan *essential* dan *non-essential*.
