

GUIDELINE ON APPLICATION FOR TAX INCENTIVE FOR MWC <u>OPERATOR</u> IN MINES WELLNESS CITY (MWC)

(31.03.2021)

I. <u>INTRODUCTION</u>

- 1. The Mines Wellness City (MWC) means the area as per **attachment**. The MWC Operators undertaking qualifying activities in the MWC as indicated in Appendix A are eligible for the following incentives:
 - a) Pioneer Status (PS) with tax exemption of 70% on statutory income derived from qualifying activities carried out in the MWC for a period of 5 years starting from the date of the commencement of the qualifying activities; or
 - b) Investment Tax Allowance (ITA) of 60% on qualifying capital expenditure incurred within 5 years starting from the date the first qualifying capital expenditure incurred in the MWC. The allowance can be offset against 70% of statutory income for each year of assessment.

II. CRITERIA

- 1. The applicant must be a company incorporated under the Companies Act 2016.
- 2. A MWC Operator must carry out the qualifying activities within the MWC and licensed or approved by the relevant Ministries or Authorities.
- 3. The applicant must have a letter from Country Heights Holdings Berhad confirming that the business is carried out in the MWC.
- 4. The applicant must have a minimum paid up capital in respect of ordinary shares of RM 500,000.00 at the date of application to MIDA.
- 5. The applicant company which has not been approved other tax incentives under the Income Tax Act 1967 or the Promotion of Investments Act 1986.
- Business of MWC Operator be treated as a separate and distinct source of activity and must keep separate accounts for that business.

7. The incentive is applicable for applications received by MIDA on or after 1 January 2013 until 31 December 2026.
